

## Why Study at the Graduate School of Law,

#### 1) Disaster Science

-Tohoku University's commitment to its community role was demonstrated in the aftermath of the Great East Japan Earthquake of March 11, 2011. Tohoku University was one of the institutes of higher education at the center of the disaster area and it undertook considerable efforts toward reconstruction and revitalization of the local region. The aim of these endeavors was to establish new industries through close collaboration with industrial and government agencies so as to boost employment and invigorate the Tohoku region. These efforts have served as a stimulus to the Japanese economy as a whole.

## Welcome to

Tohoku University, formerly known as the Tohoku Imperial University, was founded in 1907. Unlike other imperial universities of that time, it initiated both technical and regular high schools. In 1913, it went a step further and became Japan's first university to admit female students, despite opposition from the government.

Since its inception, Tohoku
University has been attracting
young and brilliant researchers
from around the world as faculty
members and students. The
"Research First" Principle was thus
established, calling on scholars not
only to pursue highly productive
research but also to put their
findings into the education of their
students.

## **Tohoku University**

In addition to this, Tohoku University has a proud tradition of "Practice-Oriented Research and Education": the results of cutting-edge research are put to use for the good of society and the improvement of living standards. Thus, Tohoku University has established local venture businesses, which have contributed to the regional economy, and is recognized as the nation's center for research on family law. In 2011, Tohoku University was severely damaged by the Great East Japan Earthquake. However, it responded to the disaster by providing its expertise and support to the damaged region. Now, most of the region has gone through numerous reconstruction projects.





#### The Graduate

In April 2004, the Graduate School of Law was reorganized into a tripartite organization, which comprises the Graduate School of Law, the Law School, and the School of Public Policy.

Among these three institutes, **the Graduate School of Law** is the most important center of academic research activities, covering a wide range of fields of law and politics (note that law departments of Japanese universities have both law major and political science major). As an educational institute, the Graduate School of Law provides the Master's Course and the Doctoral Course for training future scholars in law and politics and others who wish to pursue advanced academic research; **the Law School** provides a curriculum for training future legal professionals; and **the School of Public Policy** provides one for training future government officials and others who are to develop and enforce public policies.



#### **School of Law**

Traditionally, the Tohoku University School of Law, as a matter of principle, has given special priority to academic research activities ("Research Fist Principle"). However, as contemporary society has become increasingly sophisticated and complicated, many difficult legal and political problems have come to the fore, and this in turn has necessitated a reconsideration of the significance and the social role of academic research activities. While the principal object of the Graduate School of Law is to approach various problems in contemporary society from the "theoretical" perspective, such activities also aim to provide illuminating insights into the "practical" aspects of such problems, contributing to the education in the Law School and the School of Public Policy, where questions are often raised on the relationship between theory and practice.





## **Meet Our Faculty**

Associate Prof. Kentaro Nishimoto

My research field is international law, with a focus on the international law of the sea. At the center of my research is the question of how international law continues to provide a framework for reconciling the different interests of States. Notwithstanding its universal nature, the way in which international law is interpreted, applied and approached is diverse across States and regions. My students in the CNDC program have constantly reminded me of this fact. I invite students to take advantage of this program, which provides an opportunity to enrich their research at their home institutions with insights from different perspectives.

My research field is social security law. Taking both an aging population and weakening family solidarity, Japanese society is facing serious challenges in the domain of social security. How can we make social security systems sustainable? What kind of supports should be organized in a local community? Tohoku University offers you the ideal research environment to tackle such difficult questions. I am looking forward to sharing our interests in social security law and holding discussions with you at Tohoku University.

Prof. Hiromichi Sasaki

I teach Constitutional Law and Comparative Constitutional Law, and my main research focuses on the comparative and historical study of the development of religious liberty in Japan and the U.S.A. Japan is the first country to adopt Western constitutionalism in Asia, and our constitutional experience is filled with the conflict between the Western constitutionalism and the non-Western tradition or culture. Those who are interested in that experience are especially welcome to come to Sendai and study at our Graduate School of Law.

Law is an instrument to achieve specific social objectives. In order to evaluate whether a legal rule is socially desirable or not, we need to evaluate whether it brings the intended social outcomes. I often employ economics and statistics (or data science) to analyze this issue. My research covers various areas of law, ranging from business law, corporate law, financial regulation, consumer protection law, environmental law, medical law, and criminal law. Anyone who is interested in 'scientific' analysis of law is welcome.

Associate Prof. Akira Tokutsu

My research field is Corporate Law (Company Law) and Commercial Law. Especially, cross-shareholding and ownership structure are my areas of expertise. Corporations are the engines for economics all over the world. Therefore, a variety of agendas are appropriate for comparative research. Does Corporate Law converge? Is Corporate Law different from Corporate Governance? What is the purpose of Corporate Law: shareholder primacy or stakeholder theory? We, you and I, can talk about these themes through various topics: shareholder derivative actions, the duty of the director, the function of independent directors and so on. I welcome ambitious international students.

Thank you for your interest in our university. I used to be an international student in Japan. After graduation, I returned to my home country and engaged in teaching for several years. Now, I teach commercial law at this university and my main research topics are related to corporate governance and disclosure regulations in the securities market. My research covers several countries, including Japan, the United States and China. I would be happy to discuss the corporate law or securities law in your country and share my experience of studying abroad with you. Looking forward to seeing you at our university.

My main field of interest is Japanese family law. The School of Law of Tohoku University has a long tradition of excelling in family law scholarship. Professor Nakagawa Zennosuke, who is considered to be the father of Japanese family law, taught and researched here for almost 40 years. Tohoku University's libraries boast of an excellent collection of books and journals for those interested in family law and related research.

My major is jurisprudence and philosophy of law. I would like to enjoy interdisciplinary communication with intellectuals who have interests in the following two topics that my current research focuses on- one is public law litigation in Japan which covers pollution cases from Minamata disease to Fukushima meltdown as well as war compensation suits filed by comfort women and forced labor victimized in World War II, and the other is history of modern Japanese morality, especially concerned with Kyoto School of philosophy and Japanese Romanticism represented by K Nishida and Y Yasuda.

My research focuses on the comparative study of political parties, legislative politics, and electoral behavior. Current research projects include studies on the effect of gender stereotypes on voter evaluation of candidates running for electoral office, the effect of foreign threats on parliamentary speeches in Japan, and a comparative study between Japan and the United States on the response styles to public opinion surveys among citizens. I also study political activities of local politicians and their relationship with voters in the Tohoku region of Japan.

My work has appeared in American Journal of Political Science, Journal of Politics, Political Behavior, Political Science

Research and Methods, and Japanese Journal of Political Science. I look forward to working with students interested in Japanese politics and empirical social science research.

I specialize in political and diplomatic history of modern Japan. My published works includes Budget Politics during the Formation of Party Government in Modern Japan: The Political Leadership of Taro KATSURA, 1900-1914 (University of Tokyo Press, 2013, in Japanese), and Japanese translation of Dr. Sheila A. Smith's Intimate Rivals: Japanese Domestic Politics and a Rising China (joint translation, University of Tokyo Press, 2018). I look forward to meeting motivated graduate students from around the world.

#### **Information on Application, Admission and Tuition Fees**


An application fee is required to take the entrance exam. In order to enrol, students must also pay entrance and tuition fees. Students who find it difficult to pay entrance or tuition fees for economic reasons may be granted a waiver of half or the entire entrance fee and/or one-third, half, or the entire tuition fee, pending an application and screening.







We confer a degree of PhD (law) on the students who achieve the following goals;


- Based on their wealth of knowledge and higher profession, the students have the skill to attain an original research and to supervise, or to engage in higher professional career;




