Nagoya University, located in Nagoya City, Aichi Prefecture, began its history in 1871 with its temporary hospital and medical school. In 1939, the Nagoya Imperial University was established, and in 1949 it was changed to Nagoya University under a new education system. In 2004, Nagoya University became a national university with a new governing structure.

Nagoya University maintains a free and vibrant academic culture with the mission of contributing to the well-being and happiness of humankind through research and education.

The Graduate School of International Development (GSID) pursues a mission to promote understanding of the problems we face in the globalizing world and to create a sustainable society by contributing to policy-making and implementation by international organizations, governments, and civil society organizations. In order to find solutions to contemporary problems, technical approaches are often not enough. We need to understand the existing policy frameworks and apply innovative thinking based on social science perspectives. GSID thus attempts to cultivate courageous intellectuals capable of finding such solutions by promoting policy-oriented, interdisciplinary research and teaching in cooperation with a network of academic and research institutions and implementing agencies. Our objectives are as follows:

1. Promote empirical research based on social science theories and methods that can inform the policy-making and implementation processes of the international community, governments, and civil society;
2. Train professionals who can contribute to state- or community-building cooperation with the international community and with a full understanding of national and local realities;
3. Expand our worldwide network with governments, universities, and international organizations through research and teaching in order to realize sustainable development and just societies on the global level.

Features of the Program

In this JDS sub-program, applicants shall choose one course from the four program courses offered by GSID: "Inclusive Society and State," "Peace and Governance," "Education and Human Resource Development," and "Poverty and Social Policy."

(*Please note that, as the "Economic Development and Management" program is accepting applicants under other JDS sub-programs, those who wish to study development economics and public finance should apply to that sub-program.)

There are two distinguishing features of education at GSID, including the four courses mentioned above:
(1) GSID emphasizes practical education through both overseas and domestic fieldwork, each comprising two credits of preparatory lectures and two credits of fieldwork. JDS students who are interested in applying Southeast Asian development experiences to Sri Lanka can participate in Overseas Fieldwork (OFW), while those wishing to bring

Japanese regional development insights back to Sri Lanka may choose Domestic Fieldwork (DFW). In both cases, students have the opportunity to learn from practical experiences either in developing countries or in Japan, together with classmates from various countries worldwide.

(2) JDS students are expected to take courses necessary to address development challenges in Sri Lanka, including social research and data analysis. Relevant subjects include "Introduction to Questionnaire Survey and Interview," "Introduction to Statistics and Data Science," "Quantitative Social Science," and "Comparative Methods."

Brief Explanation of Program Courses:

(1) Inclusive Society and State (keywords: politics, law, migration)

This program course aims to understand the changing roles of the state and civil society, and to contribute to improving the lives of marginalized people in terms of class, gender, ethnicity, religion, and so on, to realize a fair, open, and inclusive society and state. It trains students to analyze dynamic processes of dominance, resistance, and cooperation in the construction of a better social order, legal frameworks, and state policies.

(2) Peace and Governance (keywords: international relations, international law, migration, peace-building)

This course focuses on peace issues as one of the key contemporary international challenges. It deals with the root causes of conflicts, reconstruction assistance in post-conflict societies, and other issues such as refugees and human rights. It also examines governance systems in both international and domestic contexts, while studying the evolving international environment.

(3) Education and Human Resource Development (keyword: education)

This course addresses issues related to educational development at global, national, and local levels. Specifically, it provides perspectives on the latest discussions concerning the SDGs and other education-related global initiatives; theories of education, and human resource development; and issues related to specific aspects of education inside and outside of schools.

(4) Poverty and Social Policy (keywords: rural development, social policy, history)

This program focuses on poverty-related issues in both rural and urban areas, affecting diverse people and societies around the world, in order to inform policy debates in international development studies. It also examines the historical evolution of development theory and practice and explores emerging frontiers in the field of development.

Necessary Curriculum to Obtain the Degrees

The Department of International Development and Cooperation, GSID offers professional education programs (hereinafter, programs), and students can obtain a certification of their major field program by completing the study requirements. Student may also obtain a minor field program certification in addition to their major field program certification. This part explains the requirements for major program certification and minor program certification.

(1) General rule of credit is:

- a. To earn 30 credits and submit master's thesis;
- b. At least 16 credits of the 30 credits indicated above must include GSID lecture subjects (excluding "Preparatory Seminar for GSID Overseas Fieldwork" and "Preparatory Seminar for GSID Overseas Fieldwork");
- c. 8 credits of the 30 credits indicated above must be seminar subjects (2 credit per semester);
- d. Up to 10 credits of other graduate school subjects can be recognized as those of the 30 credits above.

Nagoya University has more than 100 years of history and produced six Nobel laureates.
