






Countries and Regions Represented by Students





With over 100 years of tradition and history, the Ritsumeikan Academy opened Ritsumeikan Asia Pacific University (APU) in 2000 as Japan's first genuinely international university. ## MASTER OF BUSINESS ADMINISTRATION (MBA)

The MBA Program at APU prepares graduate students with advanced knowledge in international business and Japanese management techniques. Conducted entirely in English and in a culturally diverse learning environment, this both AACSB and AMBA accredited program opens up global career options for graduates looking to enter the field of international management.

With the reformed curriculum from April 2023, students are provided opportunities to engage in their chosen industry through in-class activities, field studies, internships, and business case competitions in Japan and overseas. The flexibility of the programs allows students to pursue a broad range of interests, including the ability to take Graduate School of Asia Pacific Studies and Japanese language courses to fulfill credit requirements.

Students can choose from four types of final research projects to match their interests and career goals: a business plan, internship-based case study, independent report, or master's thesis.

The mission of the Graduate School of Management (GSM) is to cultivate creative, well-rounded professionals and leaders who will play a central role in resolving management issues at globalizing enterprises and organizations. It is the only institution in the world where students can study Japanese management practices in an all-English curriculum while being immersed in a culturally diverse learning environment. In addition to advanced management skills, the students are to build innovative and global mindset, deep understanding of business ethics, and appreciation for diversity.

The Graduate School of Management has maintained an excellent reputation since its establishment. In 2009, GSM was awarded a Palms of Excellence rating of '3' in the Eduniversal Business Schools Ranking due to its status as an excellent business school with strong international influence. In 2016, GSM earned AACSB International accreditation, widely regarded as the highest level of accreditation for business schools internationally, and in 2020, it became the second business school in Japan to earn accreditation from the Association of MBAs (AMBA), granted to only 2% of business schools around the world. Such recognition demonstrates the alignment of APU's education and research with international standards as well as the university's commitment to perpetual improvement.

The Japanese Management specialization focuses on the philosophy and practices of Japanese corporations, which helped Japan to successfully industrialize. Japanese corporations, with their emphases on quality, innovation and customer service, as well as their unique style of human resource management and governance, provide an alternative to corporations that follow the Western business model. In this specialization, students will be able to assess both the successes and failures of Japanese management practices to gain a foundation for new models of corporate management in the Asia Pacific region.



In December 2019, four APU MBA students participated in an international business case competition at McGill University in Quebec, Canada. These competitions afford students the chance to gain real-world business analytical skills, showcase their own ideas, and network with other universities and industry-leading brands around the world.

The Accounting and Finance (AF) specialization discusses theories and concepts of corporate finance, financial engineering, financial institutions, financial accounting, and managerial accounting, providing students with the skills to understand and interpret financial and accounting information. The aim of the specialization is to provide students with tools in the areas of accounting and finance to formulate strategies, design control systems, and evaluate the impact of corporate strategies on various stakeholders.

## SPECIALIZATION OVERVIEW

The Management and Marketing specialization focuses on understanding and managing the human dimensions of organizations and markets. In business organizations, some of the most important actors are managers, employees and customers, whose decisions and actions are guided by a whole range of factors, from very ‘rational’ aspects to subjective perceptions such as emotion and moral values. The constant flux of market conditions requires adaptation as well as provides opportunities for creating new market and social values. This specialization prepares students to develop multi-dimensional strategies and sustainable capabilities for organizations in order to cope with the changing business environment.



The Marketing course gives an overview of the concepts and tools necessary within organizations that create customer value. In addition, students are able to learn from one another about how business standards vary around the world.

## SPECIALIZATION OVERVIEW

The Entrepreneurship, Innovation and Operations Management specialization focuses on how businesses and product ideas emerge, develop and realize through entrepreneurship and innovation. This specialization also puts emphasis on the need for effective management of technology, production planning, operations management, supply chain management and creation and operation of new business models. It highlights the importance of innovation and creativity in launching and running a business. This specialization also addresses the issues that might arise when managing a venture through the periods of its life cycle, such as pre-establishment period, start-up period, growth period, and business expansion period.



Numerous business competitions during the program give students the chance to put theory into practice. APU has been participating the CFA Institute Research challenge since 2013 and has been part of the finals every year from 2018.


## MASTER'S PROGRAMS

### MASTER'S PROGRAM IN ASIA PACIFIC STUDIES

The Master's Program in Asia Pacific Studies aims to educate and transform students into competent leaders ready to handle challenges facing the Asia Pacific region. Individuals embarking on this program should possess a high-level interest in research pertaining to one of two specializations: International Relations or Society and Culture. The broad range of issues addressed in these specializations are supported by four pillars: analytical foundation courses, core courses on the Asia Pacific region, division-specific courses, and research-oriented intensive seminar courses. Under the supervision of their chosen faculty advisors, students will formulate and conduct research that systematically reflects knowledge gained through coursework as well as fieldwork in the Asia Pacific region.

### MASTER'S PROGRAM IN INTERNATIONAL COOPERATION POLICY

The Master's Program in International Cooperation Policy aims to cultivate human resources who will contribute to a peaceful and mutually beneficial coexistence in the Asia Pacific region. Individuals entering this program should possess the ability to incorporate diverse perspectives in their research and will frame their studies around one of four specializations: International Public Administration, Sustainability Science, Tourism and Hospitality, and Development Economics. Students can further build upon their current knowledge and cultivate their research skills through a variety of workshops and seminars offered throughout the year where they can exchange ideas with leaders within their respective fields. By graduation, they will develop the practical problem-solving skills and creativity required for sustainable development within the Asia Pacific region.



The Graduate School of Asia Pacific Studies aims to shape a better world by cultivating individuals with broad knowledge across the social sciences. GSA students develop the practical problem-solving skills required to contribute to the sustainable development of the Asia Pacific region.

The interdisciplinary programs, conducted fully in English and led by faculty with experience in distinguished organizations around the world, challenge students' critical thinking, creativity, and passion for action and change. The GSA community—vibrant, stimulating, diverse, and multicultural—supports learners in the pursuit of excellence, mutual respect, understanding, and cooperation in a globalizing world. Alumni, now spread across the globe and well-positioned in their respective fields, broaden the vast network available to GSA students as they pursue their academic and career goals.

IMAT is a dual-degree program managed jointly by APU and the Institute of Applied Material Flow Management (IfaS), an innovative research institute of the Trier University of Applied Sciences. Students spend their first year studying at APU and their second year at the Zero-Emission Campus Birkenfeld in Germany.

# RESEARCH



APU is involved in a range of research projects in accordance with the needs of international society and the Japanese national research policy.

## RITSUMEIKAN CENTER FOR ASIA PACIFIC STUDIES (RCAPS)

RCAPS was established in 1996 with a mission to promote and foster research into the multi-faceted developments and challenges that face the Asia Pacific region in the 21st century. It provides valuable opportunities for research activities by sponsoring annual conferences and coordinating seminars throughout the year.

## ASIA PACIFIC CONFERENCE (AP CONFERENCE)

The AP Conference is an international academic conference held once a year at APU. Researchers and students from around the world participate to present their research and academic perspectives. In 2019, approximately 200 presenters and 350 participants from 20 countries gathered on APU's campus for the conference.

## ACADEMIC JOURNALS

- The RCAPS Journal is a non-refereed academic journal. The editorial board conducts screening of all submissions. It is open to graduate school students.
- RCAPS Working Paper Series/DOJO is an online series in which students/young researchers can publish their papers with comments by senior researchers for free.

## SUPPORT FOR GRADUATE SCHOOL STUDENTS

RCAPS provides financial subsidies for graduate school students to support them in their research endeavors.

### Master's Field Research Support Subsidy

Master's students may receive up to 75,000 JPY once in either their second or third semester for travel expenses (transportation and accommodation fees) incurred while undertaking field research or presenting a paper at academic conferences.

### Ph.D. Research Support Subsidy

Ph.D. students may receive this subsidy for various research activities such as participating in conference presentations, field research, academic programs or publishing papers in an academic journal. They may receive up to 100,000 JPY a year.

## SEMINARS

There are many seminars to support students and researchers at APU.

- RCAPS Onigiri Seminars invite speakers from outside APU to enhance network building and information sharing in Asia Pacific Studies.

Students have access to and support from a worldwide network which consists of international heads of state, ambassadors, and industry leaders (APU Advisory Committee), distinguished researchers from around the world (Academic Advisors), and institutions associated with APU's faculty members. This network also includes APU alumni who work in an array of fields and industries across the globe. Utilizing this network is indispensable for our students' careers.

Numerous seminars, workshops, and presentations by professionals working in the field today give students a clear picture of the kind of career options available to them, the current skills being sought by employers, and the type of work that suits them best. In addition, both our faculty and students also provide various consultation services to local industries and have opportunities to interact with executives at the front lines of change in their respective industries.

Proficiency in Japanese language is often a prerequisite for those seeking employment in Japan.

# STUDENT LIFE AND FACILITIES



## FACILITIES

APU's classrooms are equipped with audiovisual and computer technology, enabling our students to take part in conferences and seminars occurring in other parts of the world in real time. The APU library, part of the Ritsumeikan Network, allows students to access over 2.3 million books and publications. Graduate students have their own lounge, lockers, and computer rooms in the Faculty Office Building where they can easily consult with their supervisors during office hours.

## STUDENT LIFE

Student life at APU is an international experience like no other. The multicultural diversity of campus provides a unique environment for students to improve their communication skills and expand their networks. The Student Office at APU provides a range of services for students in terms of club activities, local exchange, homestay programs, accommodations, and visa renewal. A health clinic and counseling rooms are also available should students encounter any problems or need advice. APU makes efforts to cater to the needs of students from all over the world, with countless small comforts found throughout campus—from areas like the Quiet Space, meant for meditation, prayer, and other forms of calm reflection, to a wide variety of foods available, including APU Cafeteria's halal-friendly favorites such as Thai curry and Japanese fried eggplant.

## LIVING COSTS

The average monthly living expenses for students at APU vary depending on lifestyle but usually range from 70,000 to 100,000 JPY including accommodation. Students can purchase reasonably priced meals at our cafeteria, which offers an array of Japanese and international cuisine.

## EVENTS ON CAMPUS

The campus becomes very lively during events such as Multicultural Weeks and the annual cultural festival Tenkusai. These events are organized to showcase the multitude of languages, cultures, and talents of our student body through food, dance, film, music, and various performances.

## ACCOMMODATION

All graduate students are entitled to a room in one of APU's student housing facilities, AP House 3 or AP House 4, which helps them adapt to their new life in Japan and concentrate on their studies. At 33,000–49,000 JPY per month, all rooms are equipped with basic facilities, including internet access. Both housings are located off campus. If students wish to live in different off-campus housing or if they are coming with their family, they can find other affordable options, as Beppu is considerably less expensive than other Japanese cities for both private and shared housing. Students can also get assistance in locating and renting accommodations from Creotech, a university-affiliated company.



# BEPPU CITY

APU is located in Beppu, a small city of 120,000 inhabitants located on the coast of Kyushu, the southernmost major island in the Japanese archipelago. The city is famous for its abundance of onsen (hot spring baths), and 140,000 tons of water gush daily from over 2,000 sources, second only to Yellowstone National Park in the United States. Enclosed by beautiful mountains and the sparkling Beppu Bay, the city's historic backstreets and billowing steam clouds give it a peaceful old-town charm, and it remains a popular tourist destination for Japanese and international tourists alike. Beppu is also a mere ten minute train ride from Oita City, a vibrant city of 480,000, which served as a host for the 2002 FIFA® World Cup Korea/Japan™ and the Rugby World Cup Japan 2019™.
